Agency Fee:

Our Agency fee includes the following services to ensure your match is perfect:

- ❖ Background checks for GC & Partner Review of medical records by RE
- ❖ Third Party review of GC's insurance policy Ongoing support for both IPs and their GC's
- ❖ **Agency Fee: \$24,000** Agency fee includes psychological assessment of both the GC and her Spouse or Partner (if applicable). background and criminal check of GC and spouse/partner (if applicable), onboarding of your GC. matching of GC & IP, review of surrogate's insurance policy by 3rd party Insurance professional, referral to and/or coordination of medical procedures and screenings with your clinic, coordination of travel arrangements, referral to attorneys experienced in practice of reproductive law, oversight of escrow account (management fees separate), coordination of birth arrangements with delivery hospital, assistance obtaining birth certificates, ongoing counseling, mediation and coordination of arrangement, and managing your case from beginning to end with professional coordinators. Surrogate support and fun gifts/get togethers with other GCs, and 24-hour availability for surrogates. We handle everything your surrogacy needs for one fee. DOES NOT INCLUDE ANY LEGAL FEES OR ESCROW FEES

Payment Structure:

- ❖ \$12,000 due when signing Retainer Agreements
- ❖ \$6,000 due when Surrogate clears in-person medical screening
- ❖ \$6,000 due upon execution of Gestational Surrogacy Agreement

- ✿ Third Party fees separate and Not Included- Attorney Fees and Expenses, Clinical fees, Psych evaluation fees or MMPI (if required by your clinic) and Escrow Account fees.
- ✿ Rematching Fees: \$6,000 rematching fee if Intended Parents want new match at no fault to the surrogate. Free rematching if surrogate is ultimately disqualified for surrogacy or the GC decides to not move forward.
- ✿ Legal Fees: \$5,000- \$10,000
- ✿ Egg Donor Fees: \$10,000- \$20,000
- ✿ GC Medical Screening: \$800-\$2,500
- ✿ Psychological Evaluation: \$500- \$1,000
- ✿ Joint Evaluation for GC+ IP: \$400-\$600
- ✿ Background Checks: Included
- ✿ Escrow fees: \$1,500- \$2,000
- ✿ IVF Cycle Fees: \$15,000- \$50,000
- ✿ GC Medications: \$1,000- \$5,000
- ✿ GC Base Compensation: \$50,000+
- ✿ Health Insurance for your GC: \$400-800/mo for 12-18 months
- ✿ Review of GC's current insurance policy: included Life Insurance
- ✿ Additional GC Fees (monthly allowance, maternity clothing, med start, housekeeping, etc) \$2,500-\$4,000
- ✿ Lost Wages: varies per GC
- ✿ OB, Hospital, Delivery Charges: Up to \$15,000

✿ **Some fees you may pay depending on circumstances:**
Lost wages, meal allowance, travel expenses, Multiples, bed rest fees, C-Section, loss of organs, childcare, etc

Your total will vary based on your unique journey. Expect the total fees to be at between \$125,000- \$150,000, sometimes more. We require IPs to fund their escrow account at 150% of their GC's base compensation to begin their journey.
